2001 NIAAA Distinguished Service Award

Carol Satterwhite, CAA, who has been athletic director at Columbia (Maryland) Wilde Lake High School for 29 years, is the first woman ever to be appointed athletic director in the Howard County School District.

A physical education teacher for the past 30 years, Satterwhite has also coached girls basketball, softball, field hockey, girls outdoor track and field and golf. From 1972 to 1977, she was the physical education department chairperson.

A member of the NIAAA since 1988, Satterwhite was Maryland's state delegate to the NIAAA's Section 2 annual meetings from 1977 to 1999, and is currently the Maryland state liaison to the NIAAA. She presided at the "How to Successfully Resolve Protest Conflicts" workshop at the 1998 National Conference of High School Directors of Athletics in Las Vegas, and is an approved CAA test administrator and helped host the 2001 NIAAA Section 2 annual meeting.

At the state level, Satterwhite has been very active with the Maryland State Athletic Directors Association (MSADA), where she served as District V representative from 1986 to 1994. She has been treasurer, membership chairperson and conference registration chairperson since 1995 and had presided for various speakers at the annual MSADA conferences. She also has served on the Maryland Public Secondary Schools Athletic Association (MPSSAA) Board of Control and was chairperson of the MPSSAA District V softball and girls basketball playoffs from 1974 to 1976. In addition, Satterwhite has organized and hosted numerous regional and state competitions for field hockey, football, boys and girls soccer, volleyball, basketball and boys and girls outdoor track and field.



We Will Miss Her! Sherry Unger 1949-2002

Sherry H. Unger, Service Learning Coordinator for Prince George's County Public Schools, died suddenly in an automobile accident on Saturday, June 22, 2002 in South Carolina. Mrs. Unger, who was married for 31 years to Jerry Unger, a Northwestern High School teacher, was the devoted mother of son Barry and daughter Terry. She was formerly a social studies teacher and the athletic director at Bladensburg High School where she had been a member of the faculty for 26 years. While at Bladensburg, Mrs. Unger served as the Senior Class advisor, advisor to the Student Government Association, as the S.A.D.D./S.H.O.P. Advisor and as the Service Learning Liaison. She was named the Outstanding Educator in Prince George's County in 1990, Prince George's County Volunteer of the Year in 1999, Athletic Director of the Year for District III in 2000 and was a finalist for the NFL Teacher of the Year in 2001. She was recently inducted into the College Park Rotary Club. Mrs. Unger was born on March 30, 1949 in Eastchester, New York. She graduated from the University of Maryland College Park and earned her Master's degree in Administration at Bowie State College. Mourning her loss are innumerable friends, colleagues, and students.

NIAAA STATE LEADERSHIP TRAINING FACULTY

The Leadership Training Ad HOC Committee realized the need for more local faculty members to assist in the delivery of the Leadership Training Program course offerings. The NIAAA relies on the state coordinators to identify and train members of their presentation faculty. To be a trainer, the person must complete LTC 501, 590 and the course or courses they will instruct. The state coordinator has the responsibility to increase the local faculty, and the NIAAA has given them the leadership tools to accomplish this task. As more LTP courses are developed, the need for local education becomes even more important to the success of the Leadership Training Program. State faculty members are the key to the continued growth of the program.

To facilitate the development of local, faculty members, LTC 590 will be offered during the 2003 Spring MSADA conference to instruct any LTC course, one must complete LTC 501, LTC 590 and the course which one will be instructing.

GRADUATE DEGREE IN ATHLETIC ADMINISTRATION

Ohio University has long been recognized as one of the premier professional training institutions for candidates seeking careers in the field of sports administration. POLY LEGEND LUMSDEN DIES AT 81

Student, teacher, coach at school for 50 years

Bob Lumsden, 81, whose 50 years at Poly included time as a student, teacher, football and baseball coach and athletic director, died yesterday of complications from a stroke, heart and lung problems at Greater Baltimore Medical Center.

Lumsden died in the presence of his immediate family, according to his son, Robby Lumsden.

"My father had a living will and he told me, personally, that his desire was not to be put on life-support systems," said Robby Lumsden, whose father had three heart bypass operations over several years, beginning in 1981. "If it was to be tackled, if it was to be conquered, he wanted to be able to do it on his own."

The Poly football stadium is named in Lumsden's honor. As Poly's baseball coach from 1944 to 1967, he compiled a 383-62 record, an .861 winning percentage.

Robby Lumsden said his father had had serious health problems for the past year, but still managed to play golf three days a week at the Mount Pleasant course. But after taking a fall while walking in his Perry Hall home on Saturday, he was admitted to GBMC with possible rib damage. It was later discovered that he had cracked ribs.

While hospitalized, he suffered a stroke, which paralyzed his right side, and also a minor heart attack, his son said. Although the stroke impaired his speech, his father never lost consciousness, Robby Lumsden said, and "made every effort to communicate up until the final moment he died. "He had had the stroke and couldn't speak or swallow," said former Poly basketball coach George "Bucky" Kimmett, who visited Lumsden in the hospital Tuesday. "He was a very disciplined man whose bark was worse than his bite."

Besides Robby Lumsden, present at the bedside were his wife of 61 years, Helen; his daughter, Sherry Lumsden; another son, Stuart Lumsden, and a granddaughter, Poppy Rupert.
